
MEMORANDUM OF UNDERSTANDING BETWEEN

MEMORANDUM OF UNDERSTANDING (MOU)

between

University of Gezira; with its head office at Wad Medani, Sudan, represented here by The Vice Chancellor of the University, Professor Mohammed Warrag Omer Mohammed

and

Hue University of Agriculture and Forestry with its head office at Thua Thien Hue province, The Socilalist Republic of Vietnam, represented here by the Rector of the University, Assoc. Prof. Dr. Le Van An

Herein after referred to as "Partners"

ARTICLE I OBJECTIVE

- 1.1 This MOU provides a framework for the development of academic and educational cooperation in the fields of educational activities development, research, and training in both Universities.
- 1.2 In achieving the objective in clause 1.1, the partners shall work on the basis of reciprocity in areas of mutual interest within the parameters of their domestic laws, regulations, policies and constituent documents.

ARTICLE II

SCOPE AND AREAS OF COOPERATION

Subject to the provisions of this MOU and clause 1.2, Cooperation may be implemented in the following ways:

- 2.1 Joint research projects on issues of mutual interest.
- 2.2 Joint Projects related to innovative teaching, development of curriculum and course design.
- 2.3 Exchange and visits of academic and technical staff.
- 2.4 Exchange and visits of undergraduate and postgraduate students.
- 2.5 Joint organization of workshops, conferences, seminars, symposia and other academic meetings on matters of mutual interest.

2.6 Sharing scientific information, documentation, publications, educational and research materials where appropriate.

ARTICLE III

FINANCIAL PROVISIONS

3.1 The fund for any activity or program to be carried out or done under this MOU shall be in consultation between the two Partners and may be borne by either or both the Partners according to any special agreement by mutual exchange of letters as may be agreed between the Partners in each case.

ARTICLE IV

SUSPENSION AND TERMINATION

- 4.1 This MOU shall remain in force for a period of five years from the date of signature. Any amendment and/or modification of the MOU will require written approval by both Partners.
- 4.2 After the initial five year period, this MOU will be renewed automatically unless written notice of its termination is given.
- 4.3 Either partner reserves the right to suspend and/or terminate this MOU upon six months -written notice to the other Partner.
- 4.4 Suspension or termination of this MOU shall not affect any other commitment or agreement made prior to the termination.

ARTICLE V MISCELLANEOUS

- 5.1 Both Partners agreed that as far as the implementation of cultural and academic cooperation in different areas is concerned, subsequent executive protocols would establish possible initiatives of mutual interest, exchange of scholars (students and lecturers), joint research programs and financial contributions.
- 5.2 A detailed cooperation program shall be determined every year by the authorities, of both partners or by their representatives.
- 5.3 Any details not mentioned or covered in this MOU shall be decided by discussions and negotiations and to be agreed by both Partners.
