

MEMORANDUM OF UNDERSTANDING

BETWEEN



RAJAMANGALA UNIVERSITY OF TECHNOLOGY ISAN, THAILAND AND HUE UNIVERSITY OF AGRICULTURE AND FORESTRY, VIETNAM

This Memorandum of Understanding (hereinafter referred to as "MoU") is made between Rajamangala University of Technology Isan (hereinafter referred to as "RMUTI"), represented by Assoc. Prof. Dr.Kosit Sriphuthorn, the President of RMUTI, located at 744 Suranarai Road, Nai Muang, Amphur Muang, Nakhon Ratchasima, Thailand 30000,

And Hue University of Agriculture and Forestry (hereinafter referred to as "HUAF") represented by Prof. Dr. Le Dinh Phung, the Vice Rector for Science Management and International Relations of HUAF, located at 102 Phung Hung street, Hue City, Vietnam.

With the resolutions to strengthen our existing relationship and expand the bilateral collaboration in academic relations, as well as the recognition that education is crucial for national development, the Parties are uniquely positioned to collaborate on a range of mutually beneficial initiatives. Therefore, the Parties agree as follows:

I. Cooperation

Both parties agree to cooperate in the aspects of collaboration between their respective educational institutions, they will encourage direct contact and cooperation between their faculty members, college members, and schools.

II. Scope of Activities

Both parties will endeavor to cooperate in the areas of education and research which are of mutual interest. Within mutually acceptable fields, the following general forms of cooperation will be pursued:

2.1 Student exchange programs

2.2 Faculty/staff exchange programs

2.3 Cultural exchange programs

2.4 Joint course development

2.5 Joint research projects

2.6 Information sharing

Both parties agree to join activities, make arrangements for specific visits, exchange/develop other forms of cooperation as necessary, and utilize the results achieved in the most appropriate manner for the mutual benefit of the Parties. It is understood, by both Parties, that this Memorandum of Understanding is the first step that may lead to a more concrete agreement, especially in the areas of student and staff exchange programs.

III. Expenses

Both parties understand that all financial arrangements will have to be negotiated and will depend on the availability of funds.

IV. Cooperation on Duration

This MoU is effective for 5 (five) years from the date it is signed. Upon completion of the 5 (five) years, and with each party's consent, the MoU may be prolonged. It can be automatically renewed and continue yearly thereafter. To terminate the MoU, a party must notify the other party in writing not less than 90 (ninety) days before the planned termination.

IN WITNESS WHEREOF, the parties hereto have caused this MoU to be executed in duplicate by their duly authorized representatives. The Parties have thoroughly read and certified the MoU to be in accordance with their desires in all aspects, demonstrated by relevant signatures and seals which are set to be evidenced in the presence of the witnesses thereof and a copy to be held by the respective parties.
